# E3 Company Website & App Privacy Policy

#### 1. Introduction

The E3 Company, LLC, a Pennsylvania limited liability company, its subsidiaries and affiliates (collectively, "E3 Company", "we", "our" or "us"), respect your privacy and are committed to protecting it through our compliance with this policy ("Privacy Policy"). This Privacy Policy describes the types of information we may collect from you or that you may provide when you visit E3 Company's website or use any E3 Company application, including mobile and browser apps and software (the "Website and Apps"), and our practices for collecting, using, maintaining, protecting and disclosing that information.

Please read this Privacy Policy carefully to understand our policies and practices regarding your information and how we will treat it. This Privacy Policy may change from time to time in accordance with Section 9 below. # 2. Children Under the Age of 13

Our Website and Apps are not intended for children under thirteen (13) years of age. No one under the age of thirteen (13) may provide any personal information on our Website and Apps. As a result, we do not knowingly collect personal information from children under the age of thirteen (13). If you are under thirteen (13) years of age, do not use or provide any information on our Website and Apps.

## 3. Types of Information Collected

E3 Company and third parties working on our behalf may collect a variety of information about you, depending on your use of our Website and Apps. This information may include personal or business-related information, such as your first and last name, company name, job title, mailing address, email address, phone number, IP address used to connect your computer to the Internet, user name or similar identifier.

## We may also collect:

- a. non-identifying information such as demographic, statistical or aggregated information, which may be derived from personal information.
- b. technical information, including your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, or information about your internet connection, the equipment you use to access our Website and Apps, and usage details.
- c. Information about your interactions with our Website and Apps, including the full Uniform Resource Locators (URLs), clickstream to, through and from our Website and Apps (including date and time), products you viewed or searched for, page response times, download errors, length of

visits to certain pages, page interaction information (such as scrolling, clicks and mouse-overs), methods used to browse away from the page, or any phone number used to call out customer service number.

### 4. Method of Information Collection

On our Website and Apps, E3 Company and third parties working on our behalf may also place, view and/or use "cookies", web server logs, web beacons and other electronic tools to collect information about your use of our Website and Apps. We also collect the content, communications and other information you provide when you use our Website and Apps and other products. This information can include information in or about the content you provide (e.g., metadata), such as the date the file was created.

## 5. Use of Information

We use information that we collect about you or that you provide to us:

- a. to provide access to our products, services and customer support, and to assist with the technical functioning of our Website and Apps;
- b. to provide you with information, products or services that you request from us;
- c. to carry out or obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection;
- d. to notify you about any changes to changes to our Website and Apps or any products or services we offer or provide through them;
- e. to answer your questions, queries or complaints; and
- f. for any other purpose with your consent.

#### 6. Disclosure of Your Information

We may disclose your information, including personal information, that we collect or you provide as described in this Privacy Policy:

- a. to contractors, service providers and other third parties we use to support our business;
- b. to comply with any court order, law or legal process, including to respond to any government or regulatory agency's request, in accordance with applicable law;
- to produce relevant documents or information in connection with any litigation, arbitration, mediation, adjudication, government or internal investigations or other legal or administrative proceedings;
- d. in connection with a sale or other transfer of all or some of the assets of E3 Company and/or in connection with a sale or merger of E3 Company or any affiliate or subsidiary;
- e. to enforce our Terms of Use and other agreements, including for billing and collection purposes;
- f. if we believe disclosure is necessary or appropriate to protect the rights, property or safety of E3 Company, our customers or others;
- g. to fulfill the purpose for which you provide it; and
- h. with your consent.
